I. FLORIDA STATE CASES – STEFANIE LINCOLN

- **Ad Valorem Taxes: ten per cent cap does not apply to residential property that changes its classification from homestead to nonhomestead, but does not change ownership** - [Orange County Property Appraiser v. Sommers](#), No. 5D11-240 (Fla. 5th DCA Apr. 20, 2012) (reversing final judgment)
- **Default Judgment: default final judgment was improper where court was without jurisdiction to grant relief requested because sec. 713.12 does not impose personal liability for breach on non-contracting spouse** - [Mullne v. Sea-Tech Construction, Inc.](#), No. 4D10-4889 (Fla. 4th DCA Apr. 18, 2012) (reversing order denying defendant's motion to vacate default judgment)
- **Foreclosure: trial court abused its discretion in denying motion to continue summary judgment hearing without allowing defendant to complete discovery on material issues** – [Harvey Covington & Thomas, LLC v. WMC Mortg. Corp.](#), No. 1D10-4047 (Fla. 1st DCA Apr. 17, 2012) (reversing summary judgment)
- **Foreclosure: summary judgment is improper where plaintiff failed to affirmatively refute defendant's affirmative defenses** – [Thomas v. Ocwen Loan Servicing, LLC](#), No. 1D11-2212 (Fla. 1st DCA Apr. 17, 2012) (reversing summary judgment)
- **Attorneys' Fees: Fla. Stat. 57.105, providing for attorneys' fees against losing party, cannot be enforced against the United States** – [U.S. v. Wonders](#), No. 2D11-2746 (Fla. 2d DCA Apr. 18, 2012) (reversing judgment awarding attorneys' fees)
- **Foreclosure: bank failed to establish its standing by showing that it possessed the note when it filed the lawsuit, thereby precluding summary judgment** – [Gonzalez v. Deutsche Bank Nat'l Trust Co. as Indenture Trustee for Am. Home Mort. Inv. Trust 2006-1](#), No. 2D10-5561 (Fla. 2d DCA Apr. 20, 2012) (reversing final summary judgment)
- **Foreclosure: bank satisfied best evidence rule by entering into evidence at trial a copy of**

original note already on file with Court – [Deutsche Bank Nat'l Trust Co. v. Clarke](#), No. 4D10-3156 (Fla. 4th DCA Apr. 18, 2012) (reversing final judgment granting motion for dismissal)

- **Foreclosure: Trial court lacked jurisdiction to rule on motion to set aside foreclosure sale because motion was a mere attempt to relitigate issues already decided** – [Flagstar Bank, F.S.B. v. Cleveland](#), No. 4D10-4194 (Fla. 4th DCA Apr. 18, 2012) (reversing order setting aside foreclosure sale and final judgment of foreclosure)

II. 11TH CIRCUIT CASES – JIN LIU

- **HAMP: There is no implied private right of action under Home Affordable Modification Program (HAMP)** – [Miller v. Chase Home Finance, LLC](#), No. 2:10-cv-00206 (11th Cir. Apr. 19, 2012) (affirming dismissal of complaint)

III. TITLE INSURANCE CASES – CHRIS SMART

- **Class Action: Section 8 of RESPA requires individualized inquiries into services and compensation provided by each transaction which prevent class treatment** – [Howland v. First Am. Title Ins. Co.](#), 672 F. 3d 525 (7th Cir. Mar. 6, 2012) (affirming denial of class certification)
