**Update us on your current role.** I am deputy general counsel of Southeast Toyota Distributors, the world's largest independent distributor of Toyotas. I support our business and leadership in a broad variety of areas, but primarily offer the most support in the areas of franchise laws and marketing. **What is the most interesting trend in your industry?** Currently, the most interesting trend is the unprecedented demand on the automotive industry. Much like the residential real estate market, there is almost not enough new car supply to meet the demand, which has also

placed an unprecedented demand on the used/pre-owned market. We are also seeing more dealerships with low inventory as a result of high customer demand and supply chain constraints.
