Compliance Counseling and Training

Our team drafts corporate immigration policies and provides training and training materials to clients' HR, compliance, and legal departments. We handle all issues related to:

- Completion and maintenance of I-9 employment verification forms
- E-Verify use, including desk reviews by the monitoring and compliance verification unit of U.S. Immigration and Customs Enforcement (ICE)
- Preparation for ICE audits or raids, including those that occur at hospitals, nursing homes, and other health care facilities, restaurants, and hotels
- H-1B public access files (PAFs)
- Fraud Detection and National Security Directorate (FDNS) visits to employer sites that employ foreign nationals on temporary work visas
- Audits and reviews of student records pursuant to the student and exchange visitor information system (SEVIS) for universities/academia
- SEVIS audits for flight academies that train pilots

Work Visa Processing

We counsel clients on the full range of visas that enable foreign nationals to work in the United States, and help clients to process all related paperwork. Our services include:

- Permanent employment-based visas/labor certification

Green Card - Immigrant Visa Processing

EB-5 Investor Program


