

# Carlton Fields Ranked Top Firm and Attorneys Named Legal Leaders in Florida Trend Magazine's 2017 "Legal Elite"

*Florida Trend* magazine ranked Carlton Fields a top firm with the most attorneys listed to the "Legal Elite" list (18) and a top five firm with the most women honorees. Five firm attorneys were listed on the *Florida Trend* Legal Elite Hall of Fame list, which is now in its ninth year.
