## Overview

Nancy Faggianelli represents business clients, financial institutions, and insurance companies in class actions and complex litigation in state and federal courts. Nancy has tried cases in the areas of breach of contract, insurance, infringement of intellectual property rights, defamation, employment discrimination, and product liability, and she has won injunctions in cases involving intellectual property rights, noncompetition agreements, and tortious interference with business relationships.

Nancy also has extensive experience in product liability cases, having tried two smoking and health cases for a major tobacco company, one of which was featured as the "Verdict of the Week" in the *National Law Journal*, and having defended over 20 other cases that were dismissed or resolved on summary judgment.
