Financial Services Update

- RESPA / QWR / Damages Allegations: Borrowers sufficiently pleaded damages arising from lender's deficient QWR responses - Ranger v. Wells Fargo Bank, N.A., No. 17-11131 (11th Cir. Dec. 11, 2018) (reversing dismissal of RESPA and negligence per se)
- RESPA: 12 C.F.R. § 1024.41(g) prohibits a servicer from "mov[ing] for foreclosure judgment or
 order of sale, or conduct[ing] a foreclosure sale[,]" but does not prohibit servicers from taking
 steps to prepare for a foreclosure sale Edge-Wilson v. Wells Fargo Bank, N.A., No. 18-cv-03302PJH (N.D. Cal. Dec. 7, 2018) (dismissing second amended complaint for failure to allege a
 cognizable injury).
