Stapleton joined the committee in 2002. As the organization’s 77<sup>th</sup> president, she oversaw the national College Football Playoff Semifinal game in the first year of the current post-season system. Stapleton also spearheaded a girls’ golf program through the committee.

Stapleton has also served for many years as a Board of Trustees and Directors member for Baptist Health Enterprises, Baptist Health South Florida Medical Arts Surgical Center, and Baptist Outpatient Services. She is an adjunct professor in the University of Miami School of Law’s Litigation Skills program. She is active in the American Bar Association Section of Litigation. In addition to her work as editor of the *Litigation Journal*, she served as Co-Director of Divisions for the Section of Litigation as well as chair of numerous other committees.
