He primarily advises commercial developers, property owners, and tenants in a variety of transactional matters. His clients also include wealthy individuals, families, trusts, and small and midsize businesses. Prior to joining Carlton Fields, Friedman ran his own firm for more than 25 years. He manages all aspects of legal work on behalf of clients, including strategy, negotiation, and documentation of agreements involving a wide variety of corporate and real estate transactions. His practice includes entity formation, acquisition, development, joint venture documentation, financing, and sales.
