- *Davis v. Einstein Noah Rest. Grp., Inc.*, No. 4:19-cv-00771 (N.D. Cal. Oct. 23, 2019). Meredith won the dismissal of all class action claims against her clients, Einstein Bagel and Caribou Coffee, eliminating any class damages and leaving the plaintiff's individual claim at \$1,000 or less. The lawsuit, which alleged violations of the Fair Credit Reporting Act, California's Investigative Consumer Reporting Agencies Act, and California's Unfair Competition Law, was dismissed with prejudice on enforcement of a class action waiver in the arbitration agreement.
